ENDOWMENT CARE SERVICES

<u>ENDOWMENT CARE</u> is a method of arranging for each season's care on a continuous never-ending basis, to the extent that the income derived from such amount will permit, as provided in Section 1501 Not-For-Profit Corporation Law. Upon payment, the sum of **\$4,014.00** is deposited into a special <u>Endowment Care</u> fund, and the income arising therefore is used continuously to care for the grave(s). This fund is under supervision of the New York State Cemetery Board.

PRICES ARE QUOTED PER GRAVE

Services provided by continuous care, are the cleaning, weeding and trimming of the grave(s). It does **NOT** include repairs to monuments or bases. It does **NOT** include planting or replacement of plants. These are additional costs. The amount of which depends upon your selection, and are to be paid for in a <u>SEPARATE</u> <u>REMITTANCE</u>. (NOT SUBMITTING A SEPARATE REMITTANCE WILL UNDOUBTEDLY CAUSE A DELAY IN <u>PROCESSING</u>). Damages caused by storms, weather, and vandalism are **NOT** included.

Upon receipt of payment, an <u>ENDOWMENT CARE CERTIFICATE</u> will be issued to the depositor. Please allow 4 - 6 weeks for the certificate to be mailed.

<u>ANNUAL CARE</u> is a method of arranging for each season's care on a yearly basis. <u>ANNUAL CARE</u> includes the cutting, weeding and trimming of the grave(s). It does <u>NOT</u> include the plantings, watering, or replacement of plants, repairs to monuments or any damages caused by storms, weather and/or vandalism.

<u>ANNUAL CARE</u> services begin in April and end in December of each year. When payment is remitted it is for <u>ONE SEASON ONLY</u> regardless of when payment is made. <u>ANNUAL CARE</u> service begins after payment is received.

The <u>ANNUAL CARE</u> fee is for keeping the grave(s) clean and trimmed <u>ONLY</u>. If the grave(s) has/have not been under care for the past year, there will be an <u>INITIAL CLEANING</u> fee. Minimum charge for <u>INITIAL CLEANING</u> is \$132.00 If care services are being transferred to Baron Hirsch Cemetery from an outside contractor, please check ______.
